#### 1. INTRODUCTION:

The National Institute of Design (NID), Ahmedabad, Gujarat, India, is a statutory premier institution (Government of India declared NID as an Institute of National Importance by NID Act 2014) set up by the Ministry of Commerce & Industry, Government of India, for design education, training, research and consultancy services in various disciplines of design. NID is a grant-in-aid institution under the aegis of the Ministry of Commerce & Industry. It has campuses at Ahmedabad, Gandhinagar & Bengaluru and an office at New Delhi.

#### 2. NOTICE INVITING e-TENDER:

The National Institute of Design (NID), Ahmedabad invites online Tender from reputed, experienced and eligible Agencies, under "TWO BID SYSTEM" for selection of an expert agency for the purpose of Supply, Installation, Testing & Commissioning of Biometric systems and it's AMC at NID, Ahmedabad, Gandhinagar & Bengaluru Campuses and Delhi office.

Tender notices and Tender documents related to this Tender are available on websites: www.eprocure.gov.in, www.nprocure.com and www.nid.edu & CPPP.

Vendors are requested to submit their RFP on www.nprocure.com only, in addition to submission of hardcopy of Technical Bid only, at Chief Administrative Officer, NID, Paldi, Ahmedabad. Any modification and/or corrigendum to this Tender/ corrigendum, etc. will be available on these websites only.

NID reserve the right to accept or reject any or all Tenderers without assigning any reason.

**"TWO BIDS SYSTEM"** shall be followed for this tender. Tenderer should take due care to submit the tender in accordance with requirement in e-Tender. Bids received shall be evaluated as per the Criteria prescribed in the tender document. NID will not entertain any modifications subsequent to opening of bids and bids not conforming to tender conditions shall be liable to be rejected. Therefore, bidders are advised to submit their bids complete in all respects as per requirement of tender document specifying their acceptance to all the clauses of Bid Evaluation Criteria, General terms and conditions and compliance to the Scope of Work requirement etc.

#### **Eligibility Criteria and evaluation process/method for the Technical Bids Evaluation:**

The Institute shall evaluate the Technical Bids on following major criteria. **Annexure-B** is to be filled up with full details, copies of the necessary documents, testimonials etc. should be attached, for the evaluation process.

- a. The bidder should submit copy of valid Trade License, PAN and GST Registration No. with the Technical bid of Tender documents.
- b. The bidder should submit the Income Tax return for last three previous Financial Year ending **31**<sup>st</sup> **March 2022** with the Technical bid of Tender documents. (FY 21-22, 20-21,19-20).
- c. The annual turnover in the business of Supply, Installation, Commissioning, Testing and Maintenance of Biometric Attendance System of the bidder should be minimum Rs.5,00,000/- (Five Lakhs only) each year during the last 3 years. The details to be furnished by the bidder in the technical bid giving the audited profit & loss account and balance sheet for last three years ending **31**<sup>st</sup> **March 2022**. It should be duly attested by Chartered Accountant.
- d. The Bidder should have successfully implemented similar orders / work of Supply, Installation, Commissioning, Testing and Maintenance of Biometric Attendance System as listed below during the last 3 years period from **(FY 2019-20 to 2021-22)**:

One similar work in last three years period from **(FY 2019-20 to 2021-22)** costing not less than 80% of the present estimated cost this tender and also the strength not less than **500** students/staff in Universities/Institutes/Colleges/PSU/Corporate Sector

#### OR

Two similar works in last three years period from **(FY 2019-20 to 2021-22)**costing not less than 60% of the present estimated cost this tender and also the strength not less than **300** students/staff in Universities/Institutes/Colleges/PSU/Corporate Sector

#### OR

Three similar works in last three years period from **(FY 2019-20 to 2021-22)** costing not less than 60% of the present estimated cost this tender and also the strength not less than **300** students/staff in Universities/Institutes/Colleges/PSU/ Corporate Sector

[Mode of proof: Copy of Purchase Order/Contract for providing 'Award of Work'. Copy of Completion Certificate'/Final Invoice/Letter indicating return of Security Deposit for providing satisfactory 'Completion of Work' should be furnished for each of the said projects, along with your bid.

- The Main office or full fledge working branch office of the Vendor should be in Gujarat else the bid will be summarily rejected.
- Vendors to have present clients based in Ahmedabad/Gandhinagar.
- Earnest Money Deposit (E.M.D): Rs. 5,000/- (Rupees Five Thousand Only) by way of D.D./ P.O in favour of National Institute of Design payable at Ahmedabad to be submitted.
- The Institute reserves the right to inspect one or more sites of the bidder and interact with the principle employer's authorized official, before short listing of the bidders, for opening of the financial bids.
- Decision of the Institute in respect of short listing qualified contractors shall be final, in the evaluation of the Technical/Financial Bids.

#### **METHOD OF EVALUATION (PART-I) OF TECHNICAL BIDS**

The evaluation shall be done on the scale of 50 points with the following details for marking process for suitability as under

a) Year of Incorporation/Experience in relevant Business : 10 Marks (Client incorporated earlier will get more marks)
b) Turnover from the relevant business and Financial capabilities of the bidding agency : 10 Marks
c) Relevant and reputed clients.(Preference for Edu.Inst./INI/Govt./PSU): 10 marks
d) Quality of work (as ascertained from work completion Report, etc. : 10 marks
e) Present clients in Ahmedabad/Gandhinagar : 10 marks

## (Only those bidder will be shortlisted for opening of Financial Bid who shall score 35 and above marks out of total 50 marks.

The Institute reserves its right for deciding evaluation criteria, its interpretation, assigning weightages, evaluation committee formation, site-visits, interaction with the clients of the bidders, etc. for the process of technical evaluation and its findings and its decision shall be final for selection/shortlisting of bidders, in the interests of the Institute. In case of any dispute, the decision of the Director-NID shall be final.

### **METHOD OF EVALUATION OF FINANCIAL BIDS**

To decide the successful bidder, the Technical Bid marks shall have a weightage at 60% in the overall evaluation of the bid and financial bid shall have a weightage at 40% in the overall evaluation. Formula of Normalisation of Technical Bid for each vendor Tn=(Tb/Tmax)x100 Where Tb is the bidder's Technical score and Tmax is the Highest Technical score. Formula for Normalisation of Financial Bid for each vendor Fn=(Fmin/Fb)x100 where Fb is the Bidder's Financial Bid Value and Fmin is the Lowest Bid Value. Further 60% of Tn and 40% Fn will be taken. (individual Bidder's Tn and Fn will be added to reach the final value). The winner will be the highest of (Tnx60/100+Fnx40/100). In case the combined score of technical bid and financial bid get tie, the contract shall be awarded to the bidder having more similar experience in running a contract in educational institute.

#### A. INSTRUCTIONS TO THE BIDDERS:

#### 1. General Information:

Sealed Tenders are invited by the Chief Administrative Officer, National Institute of Design, Paldi, Ahmedabad 380007, for and on behalf of National Institute of Design, Ahmedabad for SUPPLY, INSTALLATION, COMMISSIONING, TESTING AND MAINTENANCE OF BIOMETRIC ATTENDANCE SYSTEM NATIONAL INSTITUTE OF DESIGN, AHMEDABAD, GANDHINAGAR, BENGALURU CAMPUSES & DELHI OFFICE

- A bidder may modify or withdraw his bid after submission provided that the written notice
  of modification or withdrawal is received by this office prior to deadline prescribed for
  submission of bids. No bid shall be modified after the deadline for submission of bids and
  expiration of the period of bid validity specified. Withdrawal of a bid during this period will
  result in Bidder's forfeiture of bid security.
- 2. The technical bid of the tender shall be opened by a committee nominated by the National Institute of Design, Ahmedabad Campus in the presence of the authorised representatives of the bidders, if present, at **16.00 hrs**. on **31/01/2024** in the Board Room of General Administration, NID, Ahmedabad.
- 3. The technical bids, which do not contain full information and documents called for, may be rejected. The financial bids of only those bidders shall be opened, whose technical bids are qualified. NID may ask for clarifications and /or historical documents if these existed as on last date of bid submission.
- 4. The financial bids of the tender shall be opened online.
- 5. The bidders shall submit all details, documents etc. as required in the tender document duly signed on each page. In case bidder fails to do so, NID, Ahmedabad reserves the right to reject the tender without seeking any further clarification. All the pages of tender document including the documents enclosed with it should be serially numbered. The total number of pages should be mentioned in the forwarding letter.
- 6. The bidder shall submit the copy of the tender document and addenda thereto, if any, with each page signed and stamped to confirm the acceptance of the entire terms and Conditions of the tender.
- 7. All communications with regard to this tender to be addressed to National Institute of Design, Ahmedabad, at its sole discretion reserves the right to extend last date of submission of tender and the same shall be updated in National Institute of Design, Ahmedabad, Ahmedabad Campus website and all bidders are requested to visit the website for latest updates.
- 8. National Institute of Design, Ahmedabad, reserves the right to annul the bidding process at any time without any liability for such annulment, without assigning any reason there to.
- 9. National Institute of Design, Ahmedabad, reserves the right to invite revised tenders with or without amendment at any stage without any liability for such invitation and without assigning any reason thereof.
- 10. National Institute of Design, Ahmedabad, shall notify the successful bidder through E-mail or in person confirming that their offer has been accepted. National Institute of Design, Ahmedabad, will issue the Award letter to the successful bidder. This award letter shall indicate the details of services be supplied by the bidder and the amount which National Institute of Design, Ahmedabad, shall pay to the successful bidder in consideration of the execution of the contract by them.
- 11. Upon receipt of the Purchase Order by the Contractor, he shall prepare two sets of the Agreement as per **Annexure–'E'** of the tender documents at the earliest without any

delay and complete all the formalities and submit the same to NID, Ahmedabad Campus duly executed on stamp paper for value of Rs.300/-(Rupees Three Hundred only) within 07 days from the date of receipt of Purchase Order. The agreement should be submitted by the contractor along with the required security deposit. One set of the agreement will be returned to the Contractor after the signature of authorized signatory of National Institute of Design, Ahmedabad.

- 12. At any time prior to the deadline for submission of tenders, National Institute of Design, Ahmedabad, may for any reason, suo-motu or in response to a clarification by a prospective bidder, modify the tender documents by issuing amendments (addenda/corrigenda etc.). The bidders should keep on checking National Institute of Design, website and these mentioned at page 2.
- 13. Any amendment to the tender issued will be hosted on ibid websites up to Two days prior to the last date i.e. **30/01/2024** as specified for submission of the bids. All the bidders shall verify if any such amendments(s) have been issued by National Institute of Design, before submitting their bid and shall take cognizance of and include such amendment(s) in their submission. In any case, the amendment(s), if any, shall be binding on the bidder. No separate notice/ intimation of amendments will be sent to the bidders.
- 14. Tender opening, Bidder Participation, stages of Evaluation (Technical)
  - a. Tenders will be opened at the General Administration, National Institute of Design, Ahmedabad at 1600 hours on **31/01/2024**.
  - b. Any bidder who are willing to observe the tender opening, may, in person or through his authorized representative, be present at the venue and witness the tender opening. In case of authorized representative, bidder should send a letter of authorization containing the specimen signature of their representative who is deputed to be present at the time of opening of tender. Representatives without carrying the letter of authorization will not be permitted to witness the opening of the tender. The maximum number of representatives that a bidder can depute to witness the opening of the tender will be limited to one.
  - c. The bidder or his authorized representative who are present shall sign a register evidencing their attendance. In the event of the specified date of tender opening being declared as a holiday for the National Institute of Design, Ahmedabad, the tender shall be opened at the specified time on the next working day.
  - d. The tenders will be opened in the presence of the committee members and authorized representative of bidders, if available.
  - e. The information furnished by the bidder in Cover the prescribed format supplied by the NID, Ahmedabad will form the basis for the evaluation. In exceptional cases
  - f. National Institute of Design, Ahmedabad or his representative reserves the right to obtain the additional documents /clarifications from any of the bidder without vitiating the tendering process. If, in the opinion of the National Institute of Design, Ahmedabad, information and documents supplied in support of the tender do not indicate meeting the requirements of the tender specifications, the tender may be determined as non-responsive and may be rejected by the National Institute of Design, Ahmedabad.
  - g. In case the financial bid/technical bid score of more than one bidder is same as L-1, then National Institute of Design, Ahmedabad, Ahmedabad may decide L1 on the basis of turnover of bidder for last three years average.
  - h. The estimated cost of this tender is approximately Rs.5 lakh (Rupees Five Lakhs only).

#### 2. E.M.D, Guarantee and Damages

I. **Earnest Money Deposit (E.M.D)**: Rs.5,000/- (Rupees Five Thousand Only) by way of D.D./ P.O in favour of National Institute of Design, payable at Ahmedabad to be submitted

to Chief Administrative Officer Ahmedabad Campus along with Technical Bid. The bids of the bidder, who fail to submit E.M.D, shall be summarily rejected. The EMD of the bidders, who are not qualified under the technical bid, shall be returned after finalization of tender.

**Note:** No interest will be allowed on the Earnest Money Deposit from the date of its receipt until it is refunded. The EMD will be forfeited in the following cases: –

- a) In case the bidder withdraws his tender once submitted after opening tender document.
- b) If the successful bidder fails to start the project to install the Biometric Attendance System as specified in the tender document within 10 (Ten) Calendar days from the date of receipt of Purchase Order.
- c) Violation of tender terms.

### II. Security Deposit:

The amount of Security Deposit will be 10% of the tender value to be deposited by way of Demand Draft / Pay Order in favour of National Institute of Design, payable at Ahmedabad. The security deposit amount of 10% of the contract value so deposited, will be refunded within 30 (thirty) days from the date of completion of contract as per tender document, without any INTEREST.

Purchase clause: (Bio Metric Attendance Device unit shall be considered as a whole for this clause) and cost quoted at Sr. No. A (1) for quantity 1 of the financial bid shall be considered.

In the event of failure to Supply within the stipulated date/period in accordance with the specification, National Institute of Design, Ahmedabad, reserves its right, for all or any options below:-

- a. To cancel the order.
- b. To forfeit the EMD and security deposit
- c. Levy Liquidated damage @0.5% of the value of non-supplied items, per week or Part there of upto a maximum of 10% of it's cost.
- d. To avail Services from next bidders at the vendors risk, responsibility and cost. Any extra cost incurred in the procurement of the material from the alternative source will be recovered from EMD and Security Deposit as referred to earlier and if the value of the materials under risk purchase exceeds, the amount of Security Deposit, same may be recovered, if necessary, by due legal process.

#### 3. Time Period:

Within 30 working days from the issue of Purchase Order, the Contractor shall as specified in the tender documents, complete the supply, Installation, Testing and Commissioning.

#### 4. Settlement of Disputes:

The Bidder shall make request in writing to the Director, National Institute of Design, Ahmedabad, for settlement of any dispute within 30 (thirty) days of arising of the cause of dispute, failing which no disputes/claims shall be entertained by the National Institute of Design. The decision of the Director, National Institute of Design, Ahmedabad will be final and binding on the parties. The language of communication between Vendor and NID shall be English.

**5. Jurisdiction**: The Court of Ahmedabad, in the State of Gujarat only will have the jurisdiction to deal with and decide any legal matters or disputes what-so-ever arising out of this contract.

#### 6. Payment Terms:

- I. 40% of the payment will be done after successful supply of the main devices / machines. (Sl.No.A(1) of financial bid refer)
- II. Remaining payment will be made after successful installation, commissioning and testing of Biometric Attendance System and acceptance by NID.

# 7. Penalty for Late Installation/Maintenance (Without Prejudice to other remedies like Cancellation of PO, forfeiture of SD/EMD:

### 8. Place and Period of Delivery

Items pertaining to respective campuses are to be delivered at respective campuses and installed accordingly.

Delivery period will be within 15 days from the date of issuing work order/Purchase order.

Conditional/Part Tender will not be entertained by NID and such tenders are liable to be rejected.

#### C. SCOPE OF WORK:

Primarily the scope of work includes,

- A) supply and installation of approximately Total 7 Nos. biometric attendance devices, with faces detection employee's enrolment, software customization and implementation for maintaining a record of employee's attendance at National Institute of Design, Ahmedabad, Gandhinagar, Bengaluru Campuses & Delhi Office.
- B) Installation at 3 places at Ahmedabad, 2 Places at Gandhinagar, one each at Bengaluru & Delhi.
- C) Maintenance of system for three years.

# i. Specification of the software and customization including but not limited to the following:

a. The attendance software for employees to be in open source / free software; however vendors with proprietary solutions may also apply. The details of the Operating System, database server, web application framework that will be used should be clearly mentioned in the 'Technical Bid'.

**Note:** All softwares mentioned in the bid which is not free softwares and additional softwares required to run the system along with the anti-viruses needed will be bought, installed and maintained by the supplier for the term of the contract. The campus will only provide the server and network connection.

- b. Support configuration based on multi sections, multi department, multi login with different rights, and Addition and Deletion of employee as per requirement.
- c. Department wise attendance report generation indicating employee's present in specific department.
- d. The web-based user-authenticated interface to be provided for generating at least 4 customized reports portable in excel and PDF as mentioned below as per the requirement of National Institute of Design, Ahmedabad:
- e. Daily/Weekly/Monthly attendance, Late/Early attendance report facility to generate reports.
- f. Back-up of attendance record to be done at least weekly
- g. In case of server crash Re-installation, within 2 hours positively.

- o. This will also include the troubleshooting of any network issues arising in the Complete Biometric Attendance System.
- p. The responsibility of backup and retrieval of data during maintenance and service of the equipment will be with the firm.
